#### What is the Nomination Deadline?

• Thursday, 7th April, 2022.

#### Who can Nominate?

- Nominate yourself, a colleague, a peer, a superior, a subordinate or an organisation. If submitting an entry for a third party, the entry must be made with the full knowledge and co-operation of the nominee.
- All participating companies must be in operation at the time of filing their nominations
- Business / Education Groups, Holding Companies and Conglomerates may not nominate themselves as a single entity. Entities within larger group companies should apply individually. There is no limit on the number of entities that may apply from a single group company.
